A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF AVENAL CONSIDERING A SECOND AMENDMENT TO THE COMMERCIAL TRUCK PREFERENTIAL PARKING ZONES.

WHEREAS, the Avenal City Council adopted Ordinance 97-02 establishing Commercial Truck Preferential Parking Zones on public streets and adopted Resolution 97-12 to establish a specific area for parking of commercial vehicles; and

WHEREAS, the City Council adopted Resolution No. 2003-04 amending the commercial truck parking in and around the Kings Street/Tulare Street/1<sup>st</sup> & 2<sup>nd</sup> Avenue area; and

WHEREAS, the City Council finds that such parking zones are necessary in order to provide reasonable and convenient parking for the benefit of the residents of the City of Avenal; and

WHEREAS, the City Council desires to amend Resolution No. 2003-04 in order to eliminate certain areas within the Commercial Truck Preferential Parking Zone due to safety concerns;

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Avenal does hereby amend Resolution No. 2003-04 in order to amend the Commercial Truck Preferential Parking Zone as follows:





(No parking in red zones (east side corner clearance & fire hydrant clearances))

700 Block of First Avenue: Caltrans Right-of-Way

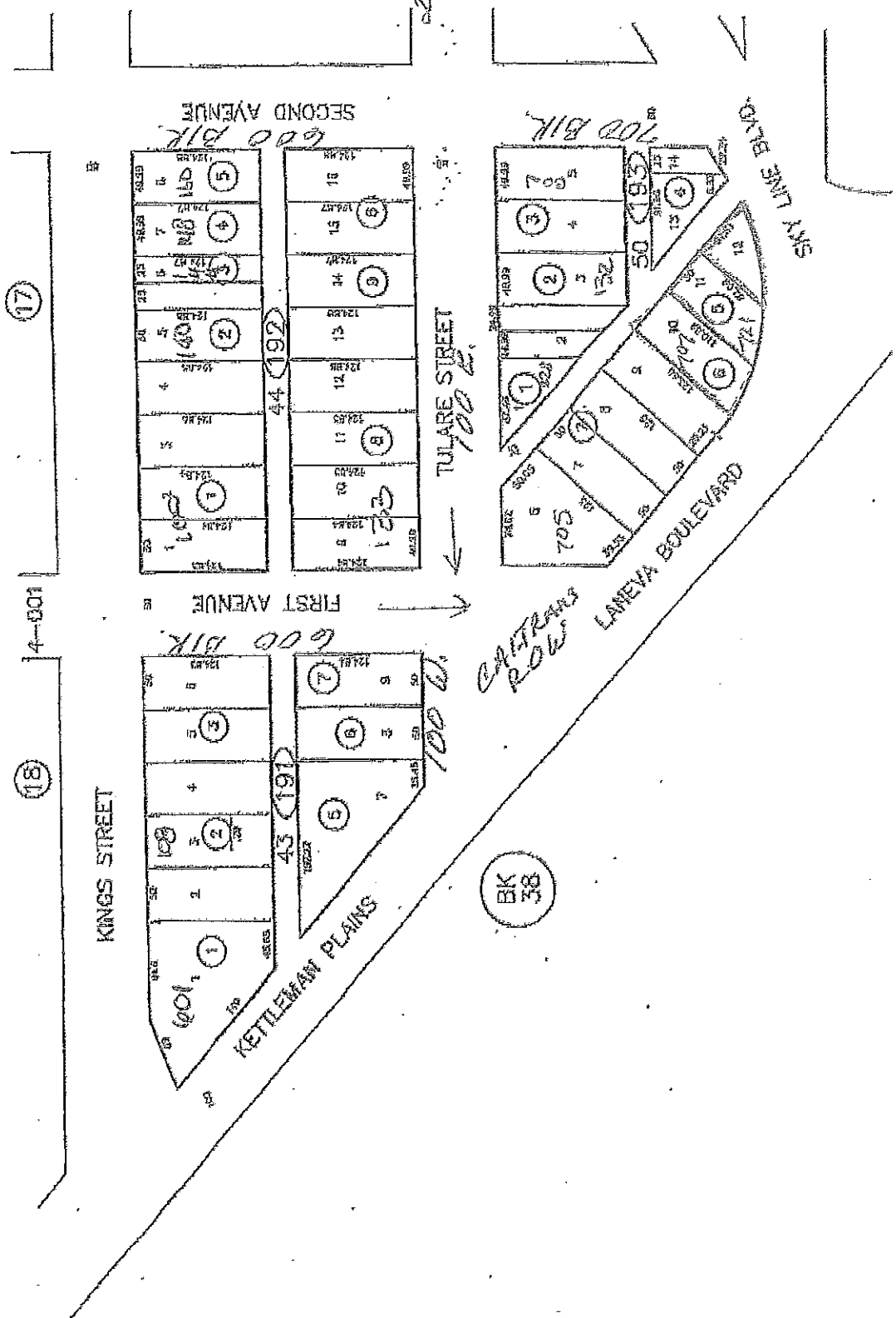
WEST 100 Block of Tulare Street: North side
